LEGACY OF DANCE ACADEMY- ("the School") Fees and Policies

Payments

Payments can be made in full by cash, cheque* or e-transfer. Cheques are made payable to: Legacy of Dance Academy

First Term Class Payment: Due upon registration (includes \$25 + HST non-refundable registration fee)

Second Term Class Payment: Post-dated cheque for December 2nd 2020

Third Term Class Payment: Post-dated cheque for February 2nd 2021

Performance Costume Deposit Payment: Post-dated cheque for November 2nd 2020

Cash and e-transfer payments must be received 2 weeks prior to the above payment dates. Payments made after deadlines are subject to a 15% late payment fee. First term payments including registration fees are non-refundable, even if student has not yet started taking a class. Those who have pre-paid in full or submitted post-dated payments automatically get their spot reserved and prioritized in the next dance term. Those who have not pre-submitted payments will be on a wait list. *NSF cheques are subject to a \$25 charge. Only a certified replacement cheque, cash or e-transfer will be accepted.

Withdrawal Policy: The school must be notified in writing 14 days prior the start of the next term to be eligible for refund. A \$25 admin fee is charged to all withdrawals. Once the term has begun, no refund will be issued for the remainder of term classes. Students are therefore encouraged to continue through to the end of the term.

With respect to classes that are cancelled by the school for any reason during the 2020/2021 dance season such as weather, pandemic, or any other unforeseen circumstance, Legacy of Dance Academy will do its best to offer alternate class days/times that fit with the school's schedule. In the event that the school cannot accommodate the alternate days/times, a future credit will be issued and must be used by December 1st 2021.

Any outstanding credits from the 2020/2021 season must be redeemed by December 1st 2020. Legacy of Dance Academy reserves the right to combine, modify, cancel classes, change instructors at any time during the school's 2020/2021 season.

Costumes

The following applies to Legacy of Dance Academy's May 30th 2021 Performance:

Upon registration, a costume deposit of \$60 post-dated for November 2nd 2020 or prior is required for each class. Costume fees range between \$60 and \$85 + HST per class per routine. Costume balances are due early spring. Please note: you must notify the school in writing on or before October 24th, 2020 if the student will not be participating in the year end performance. This notification is also required to be eligible for a costume deposit refund.

Discounts/Promotions

Early Registration: Register by June 28th 2020 and don't pay the registration fee. Regular discounts apply, but are not combinable with other promotions or discounts.

Payment Discounts: Yearly (2020/2021) payments made upfront in full are entitled to a 5% discount (before taxes, less registration fee) and are non-refundable for promotional entitlement. If taking multiple classes, payment must be made for all classes upfront for promotion entitlement. This promotion cannot be combined with any other promotion or discount. Offer expires July 19th 2020.

***Best bundled discount offer- register by June 30th 2020 and pay no registration fee (+HST), submit full upfront yearly non-refundable class fee, get 5% discount off the total base value of the class fee total.**

Multiple Class Discount: Individual students that register for a second class a week will receive a 10% discount on the lesser valued class. The 3rd class a week will be discounted at 15% discount. Additional discounts will apply if taking more than 3 classes per week. Multiple class discounts cannot be combined with siblings. Payments must be made for all classes upfront for the promotion entitlement. This promotion cannot be combined with any other promotion or discount.

Sibling Discount: After the first child registered, each additional sibling will receive a \$25.00 plus HST discount off the yearly tuition total.

Additional discounts may apply*.

LEGACY OF DANCE ACADEMY- WAIVER AND RELEASE

To: Legacy of Dance Academy (the "School")

For good and valuable consideration, receipt of which I acknowledge, I hereby waive all claims of injury, damage or loss to my person and property during my training and participation of activities at the school and release the principals, teachers, employees of the school from all actions, causes of actions and liabilities for such injury, loss, damage arising from any cause whatsoever and whether or not occasioned, wholly or in part, by an act or omission of the school, it's principals, teachers, employees, agents or other persons for whom it is responsible.

I will indemnify and save the school harmless from and against any all liabilities, claims, losses, or expenses related to the aforesaid injury, loss or damage. In the event the school shall be made a party to any litigation thereto, I shall protect and hold the school harmless and shall pay all expenses and reasonable legal fees incurred by the school in connection with such litigation. I agree to wave any and all claims that I may have in the future against Legacy of Dance Academy. I agree to release Legacy of Dance Academy and Others from any and all liability for any personal injury, death, property damage, expense and related loss, including loss of income that I or my next of kin may suffer as a result of participation in this activity, due to any cause whatsoever, including negligence, breach of contract or breach of any statutory care. I agree to hold harmless and identify Legacy of Dance Academy from any and all liability for damage to property of, or personal injury to, any third part, resulting from participation of this activity. I agree that this agreement is binding on not only myself, but also my next of kin, heirs, executors, administrators and assigns.

I also understand that Legacy of Dance Academy has the right to refuse and/or terminate my participation and/or observation in any of their classes at any time and without prior notice of causes. I also understand and agree not to take any photos, voice recordings or videos at Legacy of Dance Academy under any circumstances without prior consent from Legacy of Dance Academy. Photographs, taping, recordings or filming of participants taken by any school staff members shall become property of Legacy of Dance Academy and may be used publicity, promotional or other purposes at the sole discretion of the school.

I hereby agree and covenant not to disclose or use for performances any choreography or choreographic arrangements may have acquired, learned or developed from or at the school unless prior written consent has been obtained from the school pertaining to such disclosure or use. I warrant that the participant named on this form is physically able to participate in all dance forms provided by Legacy of Dance Academy. I declare that I have accurately disclosed all information regarding physical, emotional and or mental conditions affecting the named participant and acknowledge that Legacy of Dance Academy and Others to use in the delivery of dance program may use this information. I understand that Legacy of Dance Academy has tried to create a safe and controlled environment for participation and that the studio has established rules for participation and about the lobby, lunchroom/party room and classroom studios that must be followed by the participant at Legacy of dance Academy. I hereby give permission for emergency medical treatment to be administered to the named participant.

Legacy of Dance Academy COVID-19 Studio Guidelines Waiver/Agreement

Legacy of Dance Academy is following all guidelines and recommendations set forth by the Ontario Government and Ministry of Health as well as The Ontario Dance and Performing Arts Studio Workplace Guidelines.

- Upon arrival, please line up against the windows where yellow markings are located, students and visitors will have temperature checks conducted by our staff. We will have a self-questionnaire displayed at the entrance. Those who answer “yes” to any questions are not permitted into the facility.
- Upon entry, students will make their way to restrooms to wash their hands.
- Change rooms are temporarily closed. Students will arrive in their dance attire under their regular street clothes and will place all belongings in individual designated spaces in the dance studio. We ask that students bring only necessities, water bottles, dance shoes, etc.
- Our waiting area outside the dance rooms have markings for students to wait on while waiting for class to start. We ask that students arrive no sooner than 5-10 minutes prior to the start of their class.
- Hand sanitizer stations will be placed throughout the studio, however, hand washing is strongly recommended. Please do not be late for classes.
- Parents with children **over** the age of 6 will not be permitted into the building for the time being. Certain exceptions will be made at the discretion of the studio. **One** parent/guardian of children aged 6 and under is permitted to enter only the main waiting room area at the front of the studio and must follow all safety measures listed (eg. wearing a mask). We ask that if your child aged 6 and under does not *need* accompaniment, you refrain from entering the building as we are maintaining low occupancy and seating is limited at this time.
- Face masks are to be worn upon entrance and exit of the facility, as well as any times where appropriate social distancing cannot be maintained. Masks are not required during dance classes for students.
- Dance studio floors, barres, and walls are marked with tape to maintain 2 metres between dancers. This distance will also be kept between dancers and instructors, there will be no direct contact corrections made by instructors during class.
- Class sizes are always limited, however this year, they are narrowed down to a maximum of 7-10 students (depending on the class)
- Some classes may end 5 minutes sooner, certain classes will be staggered to avoid simultaneous group entry and exit.
- After class, parents/guardians are to wait outside the studio entrance to pick up students, a staff member will assist younger students to the entranceway to the parent/guardian.
- Kindly be on time.

At LODA, your safety is prioritized. We appreciate your understanding and are providing utmost quality to ensure our students can continue to dance and learn productively.

Note: These measures may be modified in accordance with recommendations from the Government of Ontario, Ministry of Health and The Ontario Dance and Performing Arts Studio Workplace Guidelines Any changes will promptly be made available to our community.
